

## Takiyah Worthy Education Agencies FY24 Budget Oversight Hearing Testimony Wednesday, April 5, 2023

Hello Chairman Mendelson, Committee of the Whole members, and Committee staff

My name is Takiyah Worthy and I live in Ward 7. My son is a third grader at E.W. Stokes East End. I currently serve as a PAVE parent leader on the Ward 7 board.

I want to thank you for your partnership and leadership on Out-of-School Time and School-Based Mental Health. We have made some progress but there is still much to get done.

Today, I'm testifying with a focus on School-Based Mental Health. Resources are still lacking across many schools in DC and evidence of this shortfall is spilling over into the community. It is especially noticeable in areas where there's a mix of younger and older school-aged children attending schools in close proximity to one another or traveling routes that overlap. Just last month, my good friend's 11-year old grandson was robbed at gunpoint for his coat. This happened on his short walk from school to home and the young man who robbed him was 15-16 years old. Two weeks later my cousin witnessed a young boy robbed for everything he was wearing on his way to school. I mean, I literally live behind my son's school...I can see the parking lot from my porch...I don't think I would ever allow him to walk to school alone.

School-Based Mental Health matters to me because my community matters to me. My child being able to walk to school safely, attend school safely and play in his neighborhood safely matters to me. A real investment in SBMH is an investment in our kids but it is ultimately an investment in the health of our community and city as a whole. It is imperative that every student and staff in every school have access to quality comprehensive mental health resources, or the victims of violence will become the offenders because they are scared, they are hurt, and they are not processing those feelings in a healthy way.

Currently only 63% of DC schools are matched with a provider and many schools are still in need of a partnership with a CBO.

In order to make this vision a reality, alongside PAVE parent leaders, I would like to see more people trained and ready to support student mental health. This can only become a reality with a funded strategy for building a pipeline of mental health professionals and ensuring we



adequately fund our existing community-based organizations so we don't lose the providers doing this important work.
