My name is Kisha Clark, a PAVE Citywide and Ward 6 PLE board Member and resident. My daughter attends Luke C. Moore High School. I am here today to speak on safe passage. It is of paramount importance that our children travel to and from school safely. In a city where academic opportunity should thrive, the specter of violence casts a shadow over our communities.

In recent years, Washington, DC has seen fluctuations in crime rates, with certain areas experiencing higher incidents of violence than others. While efforts have been made to address these issues, there's still much work to be done. I appreciate the work Assistant Chief Andre White and Captain Bellavance, Youth and Family Engagement Bureau, are doing to ensure the safety of our children. Thank you for meeting with PAVE parents to discuss safe passage and our parent solutions to address the issues.

We must protect our children. We cannot let fear dictate the lives of our citizens, especially our youngest citizens. We cannot allow shooting in metro stations and on the streets, which significant impact our children commuting to and from school. Ensuring safe passage in our city requires sustained focus on our youth. This means not only providing safe routes for them to navigate our streets but also equipping them with the knowledge and skills to make informed decisions and steer clear of danger.

Law enforcement must engage with our youth, understand their concerns, and provide them with the support they need to thrive. This requires a comprehensive and concerted effort from all law enforcement agencies, school leaders, safe passage workers, and violence interrupters working together to create a safer environment for our youth to grow and prosper. We need training that fosters trust and builds relationships between law enforcement and the communities they serve. We need training that recognizes the unique challenges that our youth face and empowers them to become agents of positive change in their own neighborhoods.

This specialized training equips officers with the knowledge, skills, and empathy necessary to effectively interact with young people in their communities. Police officers who undergo youth-focused training gain insights into the unique needs and challenges faced by young people. They learn about developmental stages, social dynamics, and the issues that impact the lives of children, such as peer pressure, family dynamics, and socioeconomic factors.



Understanding these complexities allows officers to approach interactions with youth in a more informed and compassionate manner.

Positive relationships between law enforcement and youth are essential for creating a safe environment. Youth-focused training emphasizes building trust and rapport with young people through respectful communication, active listening, and genuine empathy.
